Forms are due no later than Friday, August 13, 2010. **The Chamber will provide you with a 12 x 12 space. You must provide your own tent/canopy as well as any tables and chairs needed.** We ask that you make a commitment to staffing your booth the duration of the weekend's events. Leaving early will result in not being invited back in future years.

Any fund raising or membership activities done during James J. Hill Days must be contained to your own booth and will not be permitted in the street.
